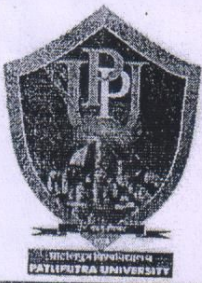



Dated : 06.02.2019

Important:

- The B.Ed. Colleges have to provide a certificate of registration from NCTE and Magadh University, Bodh-Gaya.
- The Affiliated Colleges, imparting regular education in Arts/ Science/ Commerce courses, have to provide Letter of Affiliation form the Government of Bihar.
- College Code can be used for the purposes of registration and examinations only.
- The College Code shall be valid only for the period of affiliation of the College with the university.
- The College Code shall remain withdrawn/ suspended if the institution is found to violate the norms of affiliation.
- The colleges have to furnish a certified copy of the seats allotted in different subjects (Hons. and Pass Course separately) and faculties in a soft (excel sheet) and hard copy.
- The principals of the colleges have to ensure that the number of students enrolled in various subjects should not exceed the allotted seats in any circumstances. The college is liable for disciplinary action for any violation for good conduct.
- The colleges have to send the duly certified Alphabetical List of enrolled students in various subjects (subject-wise) in a soft (excel sheet) and hard copy within seven days of closure of admission in the session/course.
